If the primary or secondary infection becomes deep-seated and tenacious, it is classified as a complicated skin and soft tissue infection (cSSTI), which includes cellulitis, necrotizing fasciitis, myonecrosis, and toxic shock syndrome. Although it may help to be able to define these more precisely, no universal grading system exists.
