### **Five Reasons to Oppose Euthanasia and Assisted Suicide**

Recently I addressed a group of Parliamentarians in London about assisted suicide and euthanasia. My talk, which coincided with World Suicide Prevention day, sought to address the unintended consequences of legalising assisted suicide and euthanasia in the Netherlands.. One of the arguments we hear is that assisted dying will bring down the number of violent suicides.

### **Legalising assisted dying can actually increase suicides ...**

This is called "Physician Assisted Suicide" or PAS. The law became effective in 1997. Washington State voters passed Initiative 1000 in 2008-NOV. Supporters call it a "Death with Dignity bill;" opponents call it an "Assisted Suicide" measure. Both are accurate descriptions. It is similar to the Oregon law.

### **Euthanasia and Physician Assisted Suicide: All sides to ...**

In the Netherlands and Belgium, euthanasia is understood as "termination of life by a doctor at the request of a patient". The Dutch law, however, does not use the term 'euthanasia' but includes the concept under the broader definition of "assisted suicide and termination of life on request".
